In 2016 Brigade Boys & Girls Club serves over 3,300 youth and teens annually in three counties (New Hanover, Pender, and Onslow) at thirteen club sites and through our school outreach and teen court diversion services. The club sites include two stand-alone buildings owned by Brigade, two club sites in public housing, six clubs in elementary schools, two in churches, and one in a community center. We serve those who need us most, which includes at-risk youth and teens who may be living in difficult circumstances, such as poverty, homelessness, foster care, single parent homes, and the military deployment of their parents. The childhood poverty rate in our service area ranges from 23% to 25% with the number of children qualifying for free or reduced lunch ranging from 48% to 64%. In 2016 we

served children representing 291 military families. Over 40% of our club members are African-American, just over 38% are Caucasian, 10.5% are Hispanic, with the balance including other racial and/or ethnic make-up. In 2016 Brigade Boys & Girls Club served over 390 at-risk teens.

During the school year, the Club sites are open after-school from 2:30 to 6:00 or 6:30 depending on community needs. One Club in Onslow County provides early morning care during the school year. Brigade Boys & Girls Club focuses on Three Priority Outcomes; Academic Success, Good Character and Citizenship, and Healthy Lifestyles.

The Formula for Impact calls for continual measurement and assessment - of Club programs and services, of our implementation of best practices and, most importantly, of youth outcomes - at both the Club level and on a national basis. Clubs now measure the same things: a set of indicators developed, based on research, to tell us how effectively we're implementing the Club experience and to assess members' progress, at various ages, toward our priority outcomes. Based on the data that these measurement efforts generate, Clubs refine and enhance their program offerings. This data is shared with Boys & Girls Clubs of America, so that it can create a meaningful picture of the Movement's national impact and identify ways in which we can continue to increase our impact.

joining a gang; being responsible or breaking the law.

New in summer of 2016, Brigade implemented a Summer Music Program. Our Kids have had the opportunity to learn to read music and play an instrument while working together as a team. Our Kids have also experienced gardening first hand. With our Enhanced Garden Project complete with indoor garden towers, outside raised vegetable beds and a new greenhouse, Our Kids have learned how to plant, care for and harvest vegetables and herbs. To take it one step further, our cooking program has used the herbs and vegetables grown onsite in their own recipes.

We have expanded our Summer Brain Gain program to include all youth at our Clubs to combat summer learning loss. Each summer in America, an estimated 43 million children in the U.S. miss out on expanded learning opportunities that could prevent them from falling behind. During summer, most youth lose about two months worth of math skills. Low-income youth also lose more than two months worth of reading skills, while their middle-class peers make slight gains.

Summer learning losses can stack up from year to year, causing low-income children to fall further and further behind, ultimately endangering their chances of high school graduation. More than half of the achievement gap between lower- and higher-income youth can be explained by unequal access to summer learning opportunities.

Also new in summer of 2016 is our YOUTH DEVELOPMENT TO WORKFORCE PIPELINE. This program is an expansion of our current Junior Staff Internship
